DEED OF GUARANTEE & INDEMNITY

8. This Guarantee shall be a continuing security for the whole of the debt that shall have been and/or shall be contracted by the Company with you.
9. My/Our obligations hereunder shall not be affected by your granting any time or indulgence or compounding with the company nor shall my/our obligations be affected by any claim whatsoever which you may have against the Company.

My liability shall continue notwithstanding the fact of our notice of my/our death, mental incapacity or bankruptcy PROVIDED HOWEVER that my/our personal representative notify you in writing to revoke the Guarantee as to the future supply of the goods and services ordered by or supplied to the Company before the receipt at any such notice.
